FALCON ACTIVITY CENTER RULES AND POLICIES

The following guidelines have been established to ensure a safe and enjoyable environment for all Falcon Community Members and Visitors

- Completed and signed Membership forms are required for use of the Falcon Activity Center.
- All members using the facility will have their information entered into our membership system and a picture of the member may be taken
- Members must scan their Membership QR Code for entry.
- Visitors must provide a photo ID and proof of age to purchase a visitor pass for entry.
- Visitors must sign the Release and Authorization Form for entry.
- Members **under age 16** must be supervised by a parent, guardian or coach in the Cardio and Weight Rooms.
- Young children are not permitted to use weights or cardio equipment.
- Student Members in **grades 9-12** may use the basketball courts and walking path without parental supervision.
- Student members **under grade 9** must be supervised by a parent or guardian in the Falcon Activity Center.
- We accept MasterCard, Visa, Discover Card, American Express and personal checks as forms of payment. A convenience fee will be applied when using a credit/debit card for payment.
- NVCSC does NOT issue any type of membership refund.
- Membership fees are NOT contingent upon facility usage.
- The North Vermillion Community School Corporation (NVCSC) reserves the right to suspend or cancel a membership if the conduct of the member is judged to conflict with other members or staff.
- Inappropriate language and behavior do not reflect Falcon Activity Center philosophy and will not be tolerated.
- All clothing must be worn appropriately. Members and guests who do not follow attire guidelines may be asked to change.
- Shirts, shorts/pants and closed-toed shoes are required during exercise in the workout areas and basketball courts. Shoes must be worn in all common areas, such as hallways.
- No cleats or spikes at any time.
- Basketball/Athletic shoes must be worn on basketball surfaces.
- No cut-out tank tops, exposing chest for males or short cropped sports bra/tops, exposing mid-section for females. The bottom of athletic tops must meet the top of pants. Shorts must cover the entire rear in all movable situations.
- Food and beverages are not allowed in locker rooms, gymnasiums, or fitness areas.
Water bottles are the exception allowed.
- Members may not lower the basketball rims.
- No dunking on the basketball rims.
- The Falcon Activity Center does not allow photography or videos to be taken in any locker room, restroom or fitness activity areas.
- The Falcon Activity Center is a smoke-free, vape free facility in and around its property.
- NVCSC is not responsible for personal property lost or stolen while using the Falcon Activity Center or on the school premises.

- There will be times when the Falcon Activity Center is reserved for athletic practices or events that may limit members' use of some or all areas of the facility. Notifications will be sent through Eventlink and the NV Falcon Activity Center Facebook page.
- NVCSC assumes no responsibility for injuries or illnesses which are sustained because of your physical condition or resulting from your participation in any athletic activities, sports programs, the use of any equipment, exercise, or any other activities or programs.
- Facility users assume the risk for any and all injuries and illnesses. NVCSC, its agents, servants, and employees are released and discharged from any and all claims for injury, illness, death, loss, or property damage, which users may suffer as a result of participation. (See Liability Authorization and Release Form)
- NVCSC or Falcon Activity Center does NOT carry accident insurance on its members or participants. All expenses incurred in the treatment of injuries due to accidents or participation will be the responsibility of the participant and his/her own insurance company.
- NVCSC has permission to use, without limitation or obligation, photographs, film, footage, or tape recordings, which may include your image or voice for purposes of promoting the Falcon Activity Center.
- NVCSC is not responsible for the actions of its staff members during periods when the staff is not performing duties specifically for the Falcon Activity Center.
- Members should report all safety issues including improper use of equipment and any repairs needed on equipment or facility to Falcon Activity Center staff.
- Please treat fellow members and staff with honesty, care, and respect. Offensive language, inappropriate behavior or attire is cause for suspension from the use of the Falcon Activity Center. Please report such behavior to a staff person immediately.
