- BPA Annual Trip will be held at ISU this year—Dec 13 (Approximately 38 students will attend)
- Truman House Talk (addiction and substance abuse) at NVHS—Dec 12
- NVHS Boys Basketball will compete in the Gobbler Classic at Rose Hulman—Nov 30
- Thanksgiving Break—Nov 27-29
- American Legion Scholarship Test at NVHS—Nov 22 (NVHS had 6 scholarship winners in 2023-2024)

- PSAT Exam Results were very positive. Ten out of fifty-two students scored high enough for the National Merit Scholarship in Language Arts and Math. Fifty-three percent who tested are on track to meet state expectations for college/work force readiness.
- WRCTE—2 students have been asked to participate in paid internships for next school year in the heavy machinery and auto programs.
- NVHS attendance rate is at 95% (grades 7-12) for the first time in at least seven years. Mr. Kirk gave credit to Mrs. Britton for calling parents, sending letters and working with the Vermillion County courthouse to improve our students' attendance.
